By signing this agreement the carer and young person fully understands that:

- The Virtual School will allocate a **Currys PC World Gift Card with the value of £500.00** to the carer of:

- **Please treat this Currys PC World Gift Card as cash.**  
**If the gift Card is lost or stolen this voucher WILL NOT be replaced by the Virtual School.**
- A total purchase of hardware, software and peripheral accessories will be made to the value of £500.00. If any further funds are required, this will be the payment responsibility of the carer and or young person not the Virtual School.
- The Currys PC World Gift Card “Terms and Conditions” must be read, understood and followed.
- The carer must be present at the time of purchase with the young person. Careful investigation and correct choices must be made together for:
  - a suitable and reliable device (laptop or tablet)
  - Software: Anti-Virus and Microsoft Office.
  - A suitable carry case.
  - Peripheral accessories e.g. printer, ink, extended warranty.
- **The purchase transaction is between the carer and the store, not the Virtual School. The carer must keep all store receipts for proof of purchase and register for the required manufacturer’s warranty.**
- The Virtual School is not responsible for **any further costs** from an internet service provider, servicing, fixing or making good any purchased items from Currys PC World.
- A full and agreed discussion between the foster carer, social worker and young person must be undertaken on setting **“Home Rules”** This must include *how, when and where* the device should be used. The rules must include responsible eSafety usage, sharing with other people in the household and consequences if the **“Home Rules”** are not fully adhered too.
- If the young person moves from the placement, all documentation and devices go with the young person to their new placement.
